**Summerset National Singles and Pairs**  
**Location: Auckland & North Harbour**  
**January 2 – January 8, 2021**



The singles and pairs events will each be played to a conclusion before the other discipline is commenced. In 2021, Men will play their Pairs event first and their Singles event second, with Women playing in the opposite order, as shown below. The tournament will again include players from the New Zealand Blind Lawn Bowls Association and the New Zealand Disabled Lawn Bowls Association.

**N.B.** Plate competitions on 3, 4 and 7 January will be single-day events arranged at club venues for those players that wish to enter them having not qualified for post-section play in their respective disciplines.
